JUSTIFICATION

The new edition of the educational-professional program 293.00.01 "International Law" was approved by the decision of the Academic Council of Borys Grinchenko Kyiv Metropolitan University on 20.06.24, Protocol No. _.

The adoption of the new edition of the educational-professional program is due to the need to bring the educational-professional program in line with the state Standard and consider the recommendations of experts and the NAQAHE (National Agency for Higher Education Quality Assurance), made during the accreditation in 2023.

During the implementation of the educational-professional program 293.00.01 "International Law" (2021 – 2023) and based on the proposals of the academic staff of the Department of International Law, European and Euro-Atlantic Integration, students, heads of internship bases, the Council of Employers of the Faculty of Law and International Relations, and in connection with the approval of the state Standard for specialty 293 International Law, the educational program was revised and amended.

These changes led to the development of a new edition of the description of the educational-professional program.

5 – Teaching and assessment

Teaching and learning	The educational process is based on the principles of student-centered, personality-oriented learning, competence-based, system-integrative approaches, research-based learning, and practice-oriented focus of learning. Teaching is conducted in the form of: lectures (including interactive lectures, binary lectures, problem lectures, press conference lectures, etc.), seminars, practical classes (including role-playing, work in small groups, discussions, drafting documents, etc.), laboratory work. Independent work is provided (completion of individual tasks, based on textbooks, manuals, Internet sources); consultations with teachers; e-learning for individual educational components, internships, completion and defense of term papers and Bachelor's qualification work. Teaching with the use of information technologies on the Moodle distance learning platform in the digital university campus, organization of communication on the Google Meet, ZOOM platforms, etc. Stimulation of self-learning of higher education students and organization of group work to acquire teamwork skills and independent problem-solving, in particular, during solving practical cases. The use of elements of non-formal education during the study of individual modules of disciplines on educational online platforms and during participation in scientific conferences, congresses, webinars, master classes, professional orientation festivals, etc.
Assessment	Cumulative grade-rating system, which provides for the assessment of students for all types of classroom and extracurricular educational activities in the form of input (testing), intermediate, final (semester) control, as well as certification. To conduct a comparative analysis of legal systems, to evaluate and argue their shortcomings and advantages, to find and interpret relevant foreign legislation, to provide advice on its content and practice of application, to assess and minimize the risks of legally significant actions, taking into account the multiplicity of legal systems and jurisdictions.

LRN6. To provide legal support for the protection of rights, the defense of the interests of individuals and legal entities, the national interests of the state of Ukraine with the help of international and national legal mechanisms in the field of public international and private international relations.

LRN7. To use the practice of the European Court of Human Rights, other international judicial and arbitration bodies, international organizations and other treaty bodies, theoretical knowledge of international law and national law to substantiate and defend one's own position, protect the interests of the client and for other professional purposes.

LRN8. To draft international treaties and related documentation (law on ratification, explanatory notes, etc.) in Ukrainian and foreign languages, to draft procedural documents, texts of draft laws, explanatory notes, comparative tables, other accompanying documentation to draft laws, to conduct diplomatic and business correspondence.

LRN9. To anticipate broad general social consequences of concluding an international treaty, taking other actions of a diplomatic or international legal nature, adopting domestic regulations, to identify relevant risks and prevent threats, in particular, in cooperation with specialists from other fields.

1. Elective block 1

«Legal Regulation of International Economic Relations»

The elective module «Legal Regulation of International Economic Relations» aims to deepen general and professional competencies within the specialty 293 «International Law» and this educational program through: the study of branches of international law that regulate international economic relations (financial, customs, environmental, investment) and the national law of Ukraine; forming students' holistic understanding of ways to resolve foreign economic disputes, the ability to resolve foreign economic disputes and represent subjects of foreign economic relations in the process of resolving foreign economic disputes through legal proceedings and arbitration.

A logically structured block of elective components is offered for study, which simultaneously aims to deepen program competencies within the chosen educational program and develop additional ones. The block is chosen at the end of the first year of study. Each semester, students have forms of assessment for different components of this block, and there is also a choice of academic disciplines from the Course Catalog, considering their own needs and interests.
